

NOTICE CALLING APPLICATION FOR MEMBERS OF TOWN VENDING COMMITTEE (T.V.C).


As per the guidelines of National Policy on Urban Street Vendors, 2009 and subsequent notification of Street Vendors (Protection of livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014) and the Goa Street Vendors (Protection of livelihood and Regulation of Street Vending) Rules, 2016, it is mandatory to constitute Town Vending Committee (T.V.C) comprising of following members:-

- a) Municipal Commissioner or Chief Officer..... Chairperson.
- b) Three members of the local authority..... Members.
- c) Collector or his representative..... Members.
- d) Chairperson of Planning and Development Authority or his representative.... Member.
- e) Chief of Traffic Police and General Police or their representatives... Members.
- f) 11 representatives of Street Vendors Association, at least one third of which shall be women..... Members.
- g) Representative of Market and Trade Association (one each) Members.
- h) Two Representatives of Non Government Organization (NGO) and one representatives of Community Based Organization (CBO)..... Members.
- i) Two representatives of Residential Welfare Association (RWA)....Members
- j) One representative of Nationalized Lead Bank of the Town/City...Members.
- k) Medical Officer from Urban/Community Health Centre..... Member Secretary.

Therefore, the Chief Officer, on behalf of Mapusa Municipal Council, Mapusa-Goa, hereby invites applications from the Street Vendors Associations, Market and Trade Association, N.G.O's/CBO's, Residential Welfare Associations (RWA's), Nationalized Lead Bank of the Town/city to represent the Town Vending Committee to be constituted by this Council as detailed above.

Following are the terms and conditions:-

- 1) The term of Town Vending Committee shall be for period of 3 years.
 - 2) The applications shall be addressed to the Chief Officer, Mapusa Municipal Council.
 - 3) The last date of receipt of applications will be 27/04/2017.
 - 4) The members at Sr. No. (a), (b), (c), (d), (e), & (k) shall be considered as the members of Town Vending Committee by default.
 - 5) If applications received for a particular category is more than the required number, the local authority shall select the member by conducting election in the manner provided in Rule 4.
 - 6) Right to accept or reject any or all the applications without assigning any reason whatsoever is reserved by the Chief Officer.
